QUALIFICATIONS:

Robinson Transport, Inc is a financially sound business that can provide a fleet of buses that Woodlawn CUSD #209 can depend on. We currently serve 14 school districts in Southern, IL and Southeast, MO and will be serving our newest district Murphysboro for the 22-23 school year. Maintenance, safety, and reliability is the backbone of our reputation.

EXPERIENCE:

Robinson Transport, Inc has been contracting school bus transportation services since July of 2000. Our President, Joyce Robinson, has been involved in the school transportation industry since 1979 as a driver and a contractor. David Robinson the Vice President has 50 years of mechanical repair, maintenance experience, and budgeting to keep our fleets safe, dependable, and up to date.

SAFETY & TRAINING:

Robinson Transport, Inc follows the State and Federal school bus driver requirements for hiring. We have internal bus driver trainers for on the road training and written test training. We have safety meetings regularly with drivers and monitors. The meetings involve but are not limited to student and driving safety on proper techniques in case of emergencies or incidents. We perform additional training for our special needs drivers and monitors on proper lift procedures and student interactions. In person instruction is used and occasionally a video for retraining. Background checks are performed on all employees before employment. DOT CDL drug testing is done on all drivers before employment and random testing throughout employment. Annual driver refresher courses are mandated by State law. We follow all FMCSA and State guidelines for training and safety.

MAINTENANCE:

Robinson Transport, Inc. follows the Department of Transportation guidelines for scheduled maintenance and inspections. We perform daily pre-trip bus inspections, every 6,000 miles or 90 days internal DOT bus inspections, bi annual safety lane inspected by DOT bus inspectors, and annual DOT bus inspections on site. These inspections may include the inspection of maintenance but not limited to all fluids, lights, emergency exits ,seats, tires, steering, exhaust, lifts, heaters, doors, and brakes.



STAFFING:


A Contract Manager, General Manager, Dispatcher, Technician, Bus Drivers, Safety & Compliance Officer, & Bus Driver Trainer / Recruiter will be serving the district. All existing current staff will be hired on approval of contract unless the district expresses otherwise.

PERTINENT INFORMATION:

- 1. Robinson Transport, Inc. offers Route 4 Me as a complimentary rostering and shared routing with the district. The software can be used to determine routes and times of routes from current enrollment. This software is not integrated with GPS and its data is manually updated and not live.
- 2. Robinson Transport, Inc. partners with Tyler Technologies for Traversa and the Ride 360 parent app. This is a rostering and routing software that integrates with GPS to give live routing and rostering information. The school district and parents can have access to the live app to check student's bus stop eta and ridership. This quote can be given if interested.
- 3. Robinson Transport, Inc. does not charge for COVID 19 disinfecting of buses. We have our drivers or monitors spray and wipe down seats and surfaces as part of their daily routes.
- 4. Robinson Transport, Inc. offers live GPS tracking of buses for the district at no additional charge. This tracking also tracks stop arm activations for pick up and drop off times verifications.
- 5. We will be paying current drivers 18.00 per hour on average for the 22-23 school year, 20.00 per hour on average for the 23-24 school year, and 22.00 per hour average for the 24-25 school years. This would include veteran drivers at upwards of 20.00 per hour for the first year with a max of 24.00 by the 24-25 school year and new drivers at 16.00 per hour with a max of 20 per hour by the 24-25 school year. We feel in order to keep routes covered with quality safe drivers the wages will have to increase at this rate.



- 6. We will maintain the fleet from our Nashville hub at 1636 Mill St. in Nashville, IL. We currently serve the Nashville Grade School, High School, & Ashley Grade School from this location. Eric Robinson will serve as the Regional Manager along with Trudy Ruess as the General Manager. We will have four technicians that will share duties from our Hub. We will have a full time driver and monitor trainer to generate new drivers and recruit in record time by monitoring our social media apps, walk in applications, fundraisers, and bus parking interviews. Our recruiters are paid to go sit at restaurants and other locations where veterans or retired folks hang out to express the needs the students and districts have for them.
- 7. We offer sign-on bonuses of 1,000.00 to 2,000.00 per driver and referral bonuses of 500.00 to our current drivers and monitors for new hires.
- 8. We will be supplying the district with 2020 Bluebirds with diesel engines for the regular routes, spares, trip buses, and 2021 Bluebirds with diesels for special routes.
